SECTION I

SUBJECT AREA AND COURSE NUMBER: HIS*G213

COURSE TITLE: United States Since 1945

COURSE CATALOG DESCRIPTION: The United States has gone through a period of rapid change since 1945. America became involved in the Cold War, the Vietnam War, Korea, and the Gulf and Iraq Wars. In the Sixties and Seventies, the civil rights and antiwar movements altered the social structure and consciousness of American society. The rise of terrorism in 2001 brought about major changes which are still underway. Through this course students will gain a better understanding of the political, military and social history of the United States since 1945. Students will learn how our society of today has been shaped by the events of this turbulent era.

SECTION II

A. SCOPE: This course demonstrates the great impact of the social, cultural, political, and military changes in the United States from 1945 to the present. In the Sixties and Seventies, the power of new ideas and new social movements such as civil rights and the antiwar movement rapidly transformed our view of ourselves and our approach to the world. Appreciation of diverse cultures grew rapidly. Students will learn how our society of today is rooted in the sweeping events of this period.

- C. ATTENDANCE AND PARTICIPATION: Students are expected to attend class regularly. Class syllabus will provide the instructor's policies.

These may include but are not limited to: lecture, class discussion, student presentations, readings and analyses of primary and secondary sources, distance learning, and use of technologies including computers, audio-visual materials and maps.
