SECTION I

SUBJECT AREA AND COURSE NUMBER: Music 103

COURSE TITLE: History of American Music

COURSE CATALOG DESCRIPTION: Development of native American idioms in folk, popular, jazz, classical, and electronic music. Lectures, discussions, recordings, and attendance at live performances are employed. Formerly listed as MUS 202, not open to students who have successfully completed MUS 202.

SECTION II

- A. SCOPE: Students of Music 103 will read, listen to, and discuss the evolution of the three genres (folk, popular, and classical) of American music. Musical terms will be used. Familiarization of the fundamental concepts of music theory, music forms, and music styles will be expected, as well as an understanding of the social, cultural, and political practices and events that shaped each genre of American music, from the settling of the New World to the present day.
- B. REQUIRED WORK: Students are expected to take notes in class, and complete all graded assignments and examinations.
- C. ATTENDANCE AND PARTICIPATION: Students are expected to attend all classes and to be punctual to all classes, listen critically to the music presented in class, and participate in all classroom discussions.
- D. METHODS OF INSTRUCTION: Methods of instruction include lecture/discussion, collaborative learning, in-class student presentations, use of technologies such as audio-visual, and computer internet, and live music performances.
