LAW 104

COURSE TITLE: INTRODUCTION TO

CONSTITUTIONAL LAW

UNITS: 3

CATALOG COURSE DESCRIPTION

This course will introduce the student to legal reasoning and provide understanding of the workings of the Federal System of justice. The focus will be on supereme court cases and the powers of the executive, legislative and judicial branches of government.

- To provide students with an understanding of the workings of the various branches of government and sources of their authority.
- 2. To provide students with an understanding of case law and its impact on criminal justice practices.
- 3. To provide students with an understainding of the nature and scope of authority of the U.S. Supreme court.
- 4. To provide students with a a review of the U.S. Constitution and relevant decisions impacting police powers.

SECTION III

1. COURSE CONTENT AND SCOPE:

A. Appropriate Reading

Reading assignments will supplement the course lectures and prepare the student for participation in class discussions.

- 1. Weekly readings will be disstributed and assigned along with the regular reading for textbook.
- 2. Handouts will be distributed for reading

B. Writing Assignments

- 1. The writing assignment will be used to measure the student's ability to communicate his/her an opinion on a constitutional issue. The student will be graded on grammar and thought.
- 2. Students will be responsible for a five (5) to ten (10) page typewritten essay on any subject related to the constitution.

C. Appropriate Outside Assignments

- 1. Reading from class books and handout material.
- One (1) typewritten essay of five (5) to ten (10) pages.
- 3. Assigned readings

D. Appropriate assignments that demonstrate critical thinking.

Critical thinking will be required of students in such assignments as the written essays, student participation at lectures, and in the student's written ability to respond to questions on mid-term and final exam.

2. METHODS OF EVALUATION:

Evaluation will be based on performance of a variety of assignments such as in class and out of class writing assignments, quizzes, essay examinations, class discussion and participation.
