MINIMUM QUALIFICATIONS: Bachelor's degree in education, psychology, sociology or human services. Candidates enrolled in a Master's Degree in Counseling/Guidance from an accredited institution and previous academic advising experience is preferred. Demonstrated understanding of the mission of the community college; excellent interpersonal and communication skills; ability to work with a culturally and ethnically diverse population; organizational and administrative ability; ability to lead/facilitate workshops and work with groups; computer and technology skills.

Applicants who do not meet the minimum qualifications are encouraged to put in writing exactly how their experience has prepared them for the responsibilities of this position and by providing appropriate references. Exceptions to the degree requirements may be made for compelling reasons

RESPONSIBILITIES: The Academic Advisor, under the supervision of the Director of Academic Advising will be responsible for: (1) providing academic counseling to new & returning students, explaining policies, procedures, and program requirements; (2) advising students in selecting courses that meet educational and career goals; (3) explaining the college's registration process; (4) explaining course prerequisite requirements; (5) reviews, interprets, and evaluates applicant test scores and other information to determine course eligibility status; (6) providing information on academic major/degree paths and explain degree/certificate programs; (7) assisting students in understanding degree requirements; (8) assisting with group orientations/registration i.e. New Student Registration Sessions; (9) working closely with other academic advisors, counselors, and college faculty and staff in order to provide timely information on course/degree options and college policies; 10) working with students on academic probation
